

The Career Services Office of the School of Law at Southern Illinois University Carbondale is pleased to develop reciprocal arrangements with other ABA-accredited law schools.

Reciprocity is available to students and graduates of other law schools under the following conditions.

A request for reciprocity must be made in writing by the requesting Career Services Office and must be received at least one week in advance of the requesting student's need for access. Visiting students attending the SIU School of Law for one or more semesters do not need to request to use reciprocity; they have the same privileges as students who are currently enrolled.

When reciprocity is approved for a student or graduate of another law school, it is granted for a three-month period which commences the day reciprocity is granted. There is no other time or date restriction on reciprocity.

Reciprocity will be granted to students and graduates of ABA-accredited law schools willing to provide reciprocal services to Southern Illinois University School of Law students and in accordance with the NALP policies posted at [www.nalp.org](http://www.nalp.org).

Students that are granted reciprocity will have access to the CORE website where the Career Services Office posts job positions. Students can also meet either in person (or by phone) with Career Services staff for career counseling. Reciprocal services may be restricted to those that the requesting law school is willing to provide in turn.

Students and graduates of other law schools will not be permitted to participate in on-campus interviews, off-campus interviews, résumé collections, or events scheduled by the Career Services Office. Students will also not have access to The Career Services Blog, emails or notices sent by the Career Services Office, or to weekly Career Services Announcements emails.

In any given year, reciprocity will not be limited to a particular number of students or graduates per law school unless the number of requests becomes cumbersome or the law school requesting reciprocity places a limit on the number of students or graduates it would provide reciprocity services to, in which case the number to whom reciprocity can be granted may be restricted to the number and time period set by the requesting law school.

Reciprocity may be cancelled or denied to any individual who misuses the services or resources of the Career Services Office. Any misuse will also be reported to the requesting Career Services Office.
