

Courses Relevant to the Illinois Bar Examination

Applicants for admission by examination to the Illinois Bar typically are tested on some, but not all, of the following subjects (based on Illinois Supreme Court Rule 704(d)). The two charts below correlate subject areas tested on the Illinois Bar with the SIU School of Law courses that address these subjects. The first list is arranged by subjects tested on the bar exam, the second by courses that address these bar subjects. Please note that these lists are offered for information purposes only. While some of the courses are required for graduation (they are indicated by **boldface type**), it is up to each student to decide how many other "bar courses" he or she wishes to take while in law school.
