**EXAM CONFLICTS:** Students must take all examinations, whether in-class or take-home, at the time and place announced either on the examination schedule or by the instructor, unless the examination is rescheduled by the Registrar for one of the following reasons: (i) a student has two examinations scheduled on the same day; (ii) a student is prevented from taking the examination(s) because of the student=s illness or a death in the student=s immediate family; or (iii) the Associate Dean has determined that a student is faced with other exceptional circumstances that justify rescheduling one or more examinations, which determination is not subject to review by grievance or otherwise.
