Hannah Brenner Johnson, Dean and Hiram H. Lesar Professor of Law Dean Brenner Johnson brings a wealth of experience as a professor, academic administrator, and nonprofit leader to her role at Simmons Law School.

Her research focuses on institutions and systems (i.e., colleges/universities, prisons, the legal profession, and the courts) and the disparate power dynamics that often exist within. She studies the perpetration of sexual violence and the related reporting,

investigation, and adjudication in closed and quasi-closed institutional settings. Brenner Johnson is also an expert on issues of inequality in the legal profession.

She has an extensive publication record of law review articles, books and book chapters. Notably, she is the co-author of Shortlisted: Women in the Shadows of the Supreme Court (NYU Press) and a legal casebook on leadership and law. Her work has been widely cited by the courts and the mainstream media.

Dean Brenner Johnson earned her B.A. and J.D. from the University of Iowa.
