**Law 517A-4 §002 Introduction to Commercial Law** (Brittingham): via Distance-Learning (Zoom), Restricted to Instructor Approval

**Law 525-3 §002 Federal Income Taxation** (Drennan): via Distance-Learning (Zoom), Restricted to Instructor Approval

**Law 531-3 §002 Trusts and Estates** (Hoke): via Distance-Learning (Zoom), Restricted to Instructor Approval

**Law 672-(2-6), §001 Judicial Externship<sup>2</sup>** (Mocsary): Open to 2L and 3L students who wish to clerk for a federal or state judge. In lieu of formal class sessions at the law school, the course will be taught online. A cumulative GPA of 2.6 is required, except that students with a cumulative GPA below 2.6 may request special authorization from the instructor to enroll in the course.

**Law 675-(1-6), §001 Public Interest Externship<sup>2</sup>** (Brittingham): Instructor permission required for enrollment in this course. Open to 2L and 3L students. A cumulative GPA of 2.6 is required. An organizational meeting of the course will be conducted at a date and time to be determined by the instructor.

**Law 514-3 §201/§202** for Limited S/U grading<sup>4</sup> **Corporate Taxation** (Morris) will be offered from 11:00 am - 1:45 pm, Tuesday and Thursday, in Rehn Hall 0024. The dates are Oct 15, 2018 - Dec 14, 2018.
