Intersession Offerings:

Law 508-1 § 401 Advanced Electronic Legal Research (Lind/Jones): Summer Intersession – class sessions will be held M-T-W-R-F from 1:00 pm to 3:00 pm from May 10 to 21, 2021 and will be delivered online.

Additional Course Offerings:

Law 590-3 § 201 Senior Writing Seminar: Labor Law (Caraway): Course delivered online via distance education. Satisfies the Senior Writing requirement.

Law 609-3 § 201 Current Developments in American Law: Election Law (Langenstein): Course delivered online via distance education/asynchronous.

Law 672 (2-6) § 101 Judicial Externship (Brittingham): Restricted to prior instructor approval. Open to 2L and 3L students who wish to clerk for a federal or state judge. In lieu of formal class sessions at the law school, the course will be taught online. A cumulative GPA of 2.6 is required, except that students with a cumulative GPA below 2.6 may request special authorization from the instructor to enroll in the course. Start date May 10, 2021. End date July 30, 2021.

Law 672 (2-6) § 201 Judicial Externship (Brittingham): Restricted to prior instructor approval. Open to 2L and 3L students who wish to clerk for a federal or state judge. In lieu of formal class sessions at the law school, the course will be taught online. A cumulative GPA of 2.6 is required, except that students with a cumulative GPA below 2.6 may request special authorization from the instructor to enroll in the course. Start date June 7, 2021. End date July 30, 2021.

Law 675 (1-6) § 101 Public Interest Externship (Brittingham): Restricted to prior instructor approval. Open to 2L and 3L students. A cumulative GPA of 2.6 is required. In lieu of formal class sessions at the law school, the course will be taught online. An organizational meeting of the course will be conducted at a date and time to be determined by the instructor. Start date May 10, 2021. End date July 30, 2021.

Law 675 (1-6) § 201 Public Interest Externship (Brittingham): Restricted to prior instructor approval. Open to 2L and 3L students. A cumulative GPA of 2.6 is required. In lieu of formal class sessions at the law school, the course will be taught online. An organizational meeting of the course will be conducted at a date and time to be determined by the instructor. Start date June 7, 2021. End date July 30, 2021.
