

**Graduation Check Request Form:**

For Students that matriculated August 2014 - August 2015

Students are expected to graduate in their third May after entering law school (this excludes the 2-Year JD Honors Program students). To graduate any time other than the third May (early), students must notify the Registrar's Office of this after registration for their final semester has taken place, but before the start of their final semester. To request a graduation check, students must complete this Graduation Check Request Form and deposit it in the Registrar's Drop Box in the Dean's Suite. The Registrar will check the student's eligibility for graduation. If a student is not eligible to apply for graduation, the Registrar will notify the student via email with the deficiency. The student will have the opportunity to make changes to their within the add/drop period to rectify the deficiency. Once cleared by the Registrar to apply for graduation, the student must complete a graduation application with the University via SalukiNet. If the student is approved for early graduation, the student's record will be updated to reflect the change in expected graduation date.
