A cumulative GPA of 2.600 is required, except that students with a cumulative GPA below 2.600 may request special authorization from the instructor to enroll in the course. Class sessions will be delivered online from 12-1pm on the following dates: June 14th and 28th, July 12th and 26th. See instructor for further details.

LAW 675-(1-6) § 201 Public Interest Externship (Page): Restricted to prior instructor consent. Open to 2L and 3L students. A cumulative GPA of 2.600 is required, except that students with a cumulative GPA below 2.600 may request special authorization from the instructor to enroll in the course. Class sessions will be delivered online from 12-1pm on the following dates: June 14th and 28th, July 12th and 26th. See instructor for further details.
