**LAW 672-(2-6) § 201 Judicial Externship<sup>3</sup>** (Page): Restricted to prior instructor approval. Open to 3L students who wish to clerk for a federal or state judge. A cumulative GPA of 2.600 is required, except that students with a cumulative GPA below 2.600 may request special authorization from the instructor to enroll in the course. Class sessions will be delivered online from 12-1pm on the following dates: June 12<sup>th</sup> and 26<sup>th</sup>, July 10<sup>th</sup> and 24<sup>th</sup>. See instructor for further details.

**LAW 675-(1-6) § 201 Public Interest Externship<sup>3</sup>** (Page): Restricted to prior instructor approval. Open to 3L students. A cumulative GPA of 2.600 is required, except that students with a cumulative GPA below 2.600 may request special authorization from the instructor to enroll in the course.
