Description: This course explores the rights of children, the legal aspects of the parent-child relationship, the state's ability to regulate the activity of children, child abuse, neglect, children in need of supervision, adoption and termination of parental rights. Although delinquency will be touched upon, criminal procedure is not a major portion of the course.

Course Materials: Children and the Law, Doctrine, Policy, and Practice, 7th Edition Douglas E. Abrams, Susan V. Mangold, Sarah H. Ramsey (West Academic)

Learning Objectives: After completing this course, students will:

- learn substantive law, public policy issues, and practice considerations in such areas as child abuse and neglect, foster care, crimes against children, child labor laws and other protective legislation, and juvenile delinquency;
- learn the importance of cross-disciplinary collaborations with experts in fields such as psychology and medicine;
- be encouraged to use their knowledge of child advocacy to participate in the public dialog throughout their careers;
- be encouraged to represent children on a pro bono basis, and to participate in bar association and other law revision initiatives, even if they specialize in other fields of law.

Structure of Course: The course is designed to expand your knowledge of the laws and policies governing children. Each class will require you to be fully prepared and ready for group discussion. I acknowledge that we will be embarking on an interesting educational journey this semester due to the continued effects of the Coronavirus pandemic. This class will be conducted online in an attempt to keep everyone healthy and safe. I understand that for some of you this is not the ideal way to learn. I encourage you to share with me any difficulties you are having during the course and I will do my best to help make sure you receive any help you need. I ask for your patience as I am as new to online teaching as you may be to online learning. I am confident that as a class we will work together to make the semester successful.

Classroom Participation: All students are expected to vigorously participate in class. You should come prepared, having read the weekly reading assignment and reviewed the chapter problems and/or notes. In order to facilitate discussion more effectively using the Zoom platform, I ask that you divide up into "firms" of 3-4 people. Each Firm will have a name—you can be as creative or basic as you wish. Your assignment for the first week of class will be to turn in the names of the individuals in your firm along with the name you have selected. Beginning in Week 2, each firm will be assigned to lead one or two weeks of class discussion. Your firm will be responsible for discussing any problems or notes in the text. Please note that even though your firm may not be "up" for any given week, you should be prepared to participate in any discussion. Your participation in the class discussion will count toward your final grade.

Practice and Writing Assignments:

Grading: Your final grade for this course will be based upon your participation in class and the final exam. The breakdown of these components is as follows:

Class participation: 5%

Final Exam: 95%

The grades of students who have elected to take this course with S/U grading will be converted by the registrar according to the following scale: 2.1 or greater = Satisfactory; below 2.1 = Unsatisfactory. Only students that earned a satisfactory grade will earn credit for the course.

Attendance Policy: The School of Law Rules primarily govern students' attendance requirements. Pursuant to those Rules, the maximum number of absences for this course is set at three (3). The sanction set out in Rule III.5(g)(iii)—a reduction in a student's final grade of three-tenths (0.3) of a point per absence—is in effect for any student who exceeds the three permitted absences.

Workload Expectations: The American Bar Association ("ABA") law-school-accreditation standards contain a formula for calculating the amount of work that constitutes one credit hour. According to ABA Standard 310, "a 'credit hour' is an amount of work that reasonably approximates not less than one hour of classroom or direct faculty instruction and two hours of out-of-class student work per week for fifteen weeks." This is a 2-credit hour class, meaning that we will spend one 100-minute block of time together each week. The amount of assigned reading and out-of-class preparation should take you a minimum of 4 hours for each class session.
