Textbook: There will be no textbook for this course. We will be using a variety of free, accessible sources. I also recommend staying in touch with an Illinois media source – the local NPR station WSIU at 91.9 fm is a decent, free option. Because we do not have a textbook, you will have a great opportunity to start reading like a lawyer instead of a law student. That means start learning to judge what parts of the reading have value to you and what parts you can skim over. This also means don't be scared by reading assignments that look large.

What you can expect to learn: State and local governments are incredibly important to our lives. They offer to educate everyone, pave our roads, put out fires and keep us safe. This semester we'll tackle what powers these governments have and where the powers come from. We'll try to figure out who participates and why.

But mostly what I want you to learn is how to be engaged in state and local government, how to advise clients about engagement in these governments, and how to advise those who have an official role in these governments. You will get a chance to polish your writing and presentation skills.

Attendance: Be here and be engaged, whether it's online or in person. I will try to make sure that class time is valuable to you. If you miss more than six classes, you will not be allowed to take the final.

Recording class sessions: I'll be recording and posting the class sessions. Keep in mind that the recoding quality is pretty low, so if you know you will be out, have a friend take notes for you.

Final exam: The final exams this semester will be held between December 2 and December 12.

Workload expectations: You might not have thought about how much work you will put into each class, but the American bar Association has! The American Bar Association standards for accrediting law schools contain a formula for calculating the amount of work that constitutes one credit hour. According to ABA Standard 310(b)(1), "a "credit hour" is an amount of work that reasonably approximates: (1) not less than one hour of classroom or direct faculty instruction and two hours of out-of-class student work per week for fifteen weeks, or the equivalent amount of work over a different amount of time." This is a three credit hour class, and through the magic of academic calculation, that's 150 minutes for each of our class session. Overall your reading, research, writing and class sessions should take an average of nine hours each week. This guideline seems pretty smart to me.
