Course Description: This course is designed to prepare you for the multi-state performance test (MPT) component of the bar exam by focusing on skill development, timing, and test familiarity. Additionally, the class will begin review of MEE essays and the rule development needed for success on those problems.

Course Objective:

The Course Objective is for students to master the skills to perform well on the MPT:

"The MPT is designed to test an examinee's ability to use fundamental lawyering skills in a realistic situation and complete a task that a beginning lawyer should be able to accomplish. The MPT is not a test of substantive knowledge. Rather, it is designed to evaluate certain fundamental skills lawyers are expected to demonstrate regardless of the area of law in which the skills are applied." http://www.ncbex.org/exams/mpt. Further, students will develop the skill of self-evaluating their own writing, to support their success during bar study and in practice.

Student Learning Outcomes:

Upon successful completion of this course, students will be able to:

- Recognize and apply the appropriate structure of the various MPT task types.
- Use appropriate structure for each style of analysis needed for the MPT task types.
- Create clear section headings and substantive headings, as appropriate.
- Have thorough and efficient use of all sources of authority in the MPT library.
- Have thorough and efficient use of all relevant facts in the MPT file.
- Create a strong, fact-driven legal analysis that is responsive to the question(s) asked.
- Organize a subject matter outline for a bar subject that can be responsive to a number of MEE style questions.

Course Delivery

The course will require completion of weekly out-of-class assignments, in-class lectures, group work, individual assignments, and a substantial individual project with presentation.

Course Workload:

ABA standards incorporate out of class work in the calculation of credit hours. Under the ABA standards, you should expect to spend at least 85 hours for work in and outside of class in this course.

Course Evaluation/Grading

Grading for this class is on a satisfactory/unsatisfactory basis. To achieve a satisfactory grade for this class, you must earn at least a 70% for this class. There will be no final exam in this course. Your grade in this course will be based on all of the following:

Weekly assignments: 60%
Graded MPT 1: 10%
Graded MPT 2: 15%
MEE rule project & presentation: 15%

A note about grading: Many assignments are graded for "completion credit." Assignments that are for completion credit are not a guarantee that any submission will earn full points. For example, a blank document or an unrelated file will not earn points. Similarly, a submission that does not reflect that the student used the structures and strategies from class, or a submission where the student did not follow instructions, will not earn full credit. If you have questions about how to earn the full completion credit for any of the completion assignments, please ask! I want to help make sure each student has the knowledge and tools to succeed in class.

A note about weekly assignments: During the course of the semester, you will be tasked with completion of multiple out of class MPT exams. After completing the exam on your own, you will be required to review a model answer and then self-evaluate your own work in comparison to the model answer. One of the main recommendations for students preparing for the bar exam is to complete a minimum of 7 to 8 MPTs during the course of your study. During the summer bar study, BarBri only assigns two MPTS as part of your course requirements. It is unlikely you will have time to get enough practice during bar study to become comfortable completing MPTS. That is why your weekly assignments will focus on completion and review of practice MPTs. As such, you should regard these homework assignments as you would if you were studying for a final exam.

Reading and Homework Assignments

You are expected to complete the reading and homework assignments **prior to each class**. These assignments will be posted on D2L. Your professor reserves the right to change assignments with sufficient notice.

Policy for Missed or Late Work & Class Preparation

Due dates for every assignment will be posted on D2L. Law is all about deadlines. Missing deadlines, being unprepared for class, or missing meetings can have dire consequences for your clients and for you (malpractice, loss of respect from the court, discipline from the bar association.) Late work will not receive full credit unless prior approval is given. That approval will only be granted in extreme circumstances that are clearly beyond your control. *Preparation* for class means reading the assigned readings, completing practice MPTS and self-evaluations, & reviewing all information required for that week.

Student courtesy policy: The classroom is a shared space where consideration and compassion for others are not negotiable.

Attendance Policy
