Course Topics:

This course analyzes legal issues surrounding agency law, partnership law, and the law of the closely held and public held corporation. Among the topics considered are: planning for the close corporation; management and control issues of corporations; the proxy system; duties of officers, directors and controlling shareholders; transactions in shares by directors and others; mergers and takeovers; and public policy implications of the publicly held corporation. The course provides students with a solid and interwoven understanding of its concepts. It is intended to be useful to both future business and nonbusiness lawyers.

Illinois, Indiana, Kentucky, and Missouri have adopted the Uniform Bar Examination, https://www.ncbex.org/exams/ube, which includes business associations. This course covers some of the topics within that purview. Some will be moving to NextGen.

Course Objectives:

At the of this course, students will be able to

- Identify the principal and agent in an agency relationship and explain their respective rights, duties, and liability under contract law;
- Identify a fiduciary and the fiduciary's duties;
- Explain the different types of agencies;
- Distinguish among partnerships, limited liability companies, and corporations and explains the rights and duties of the owners of each type of entity;
- Appreciate the various problems associated with disputes over control (i.e., proxy fights, abuses of control, and closely held corporations);
- Distinguish among a merger, acquisition, and takeover and understand the basic process of each; and
- Appreciate the different non-owner stakeholders of each type of entity and the effect on each of them regarding how the entity is organized and operated.

D2L Brightspace (D2L):

iClicker®:

Attendance:

Attendance will be taken at class meetings. If you miss more than 9 class meetings, you will not be allowed to take the final exam.

Participation:

You are expected to thoroughly read the assigned material and be prepared to discuss the subject matter during the next class meeting. Should you fail to fully participate in a class meeting, it will be considered a missed class meeting for purposes of attendance.

Why is your participation important? It's important because lectures are boring. My goal in each class meeting is to facilitate a lively discussion of the pertinent topics so we all learn from each other's perspectives, questions, and advocacy.

Workload:

You are expected to abide by the ABA standards incorporating out-of-class work into the calculation of credit hours. Using round numbers, you should expect to spend at least 9 hours per 3 credit hour class per week on your studies under those standards.

Recordings:

Do not record class meetings. Listening to a recording of a discussion another time is not an efficient way of studying law. Simmons automatically records class meetings for SIU accommodations.

Written Assignment:

During the semester, you must satisfactorily complete a written assignment to comply with the writing-across-the-curriculum and bar exam-type assessment requirement. You may not collaborate or use artificial intelligence. Failure to pass the assignment will preclude you from taking the final and result in an incomplete course grade. More details on this assignment will be provided as the semester progresses.
