COURSE DESCRIPTION: This is a senior writing seminar that introduces students to the compliance function in various health-related settings and explores the basics of healthcare compliance. As a writing seminar, students will learn advanced research, writing, citation, and legal analysis skills, culminating in a substantial independent research paper. This course satisfies the School of Law's Senior Writing Requirement which "requires the production of a paper or papers totaling a minimum of 7500 words in length, which must involve substantial research and analysis of one or more complex legal issues. The seminar shall include significant writing instruction. Faculty supervision of the student writing shall include individual formative and summative assessments, which should include at least one opportunity for students to have an individual conference with the instructor to discuss their work product and then rewrite that work product." Article III (5)(b)(i)

LEARNING OBJECTIVES:

At the end of this course, students will be able to:

- Define key terms and concepts commonly used in connection with compliance programs.
- Identify basic compliance issues, consult relevant sources of guidance on achieving compliance, and develop plans that address compliance challenges and mitigate risk.
- Articulate the need for a diverse and inclusive workforce, recognizing the impact of diversity and inclusion practices on healthcare organizations and patient outcomes.
- Analyze various laws and regulations that govern the healthcare system and understand how they are applied and enforced in the healthcare environment.

COURSE TEXTBOOK: There is no required textbook for this class.

GRADING AND EVALUATION: Research Paper (100% of final grade)

The SIU School of Law has adopted a credit hour policy in compliance with ABA Standard 310. According to ABA Standard 310(b)(1), "a "credit hour" is an amount of work that reasonably approximates: (1) not less than one hour of classroom or direct faculty instruction and two hours of out of-class student work per week for fifteen weeks, or the equivalent amount of work over a different amount

of time." This is a 3 credit-hour class, meaning that we will spend 3 hours together each week. The SIU School of Law rules do provide us with the opportunity to forgo up to four weeks of class meetings for intensive research, writing, and individual conferences on writing projects. Overall, you should plan on spending at least 9 hours each week on course-related work.

ATTENDANCE: There is a maximum of **TWO** unexcused absences for this course. A student will be withdrawn from the course on their third unexcused absence.

PLAGIARISM: Plagiarizing another's work, in whole or in part, is a violation of the Honor Code and can lead to serious penalties, including expulsion. An Honor Code investigation must also be reported to the Bar Examiners, even if you are cleared of any violation. The Honor Code defines plagiarism as:

passing off another's ideas, words, or work as one's own, including written, oral, multimedia, or other work, either word for word or in substance, unless the student author credits the original author and identifies the original author's work with quotation marks, footnotes, or other appropriate designation in such a way as to make clear the true author of the work.

COLLABORATION WITH OTHERS: You are not allowed to obtain help from any other person (including any other student) or from generative artificial intelligence (including, but not limited to, ChatGPT and Lexis AI) on the required writing assignments in this course. This ban on collaboration includes obtaining written materials from any other person or generative artificial intelligence and communicating with any other person about the assignment. If you violate the ban on collaboration policy, you will receive a failing grade on that assignment. You also may be found in violation of the Honor Code, which can lead to serious penalties, including expulsion. An Honor Code investigation must also be reported to the Bar Examiners, even if you are cleared of any violation. When in doubt about how to proceed, ask me.

Collaboration does not include discussing course work; sharing and discussing ideas, authorities, and concepts; nor reading and critiquing another student's course work. If at any point you have questions about what is permitted, contact me to discuss before submitting work.
