Course Description: This course is designed to jumpstart your bar exam preparation by developing your substantive knowledge and sharpening your skills. Specifically, you will receive in-depth review of highly tested topics in Contracts, Evidence, Torts and Real Property. You will then put that knowledge to use working through practice multiple-choice questions and integrated item sets. In addition, you will receive an introduction to the type of skills tested on the NextGen exam and tackle multiple performance tasks.

Course Learning Objectives:

Upon successful completion of this course, students will be able to:

- Effectively apply Systematic Problem-Solving strategies to MBE multiple-choice questions and essay questions
- Master rules using a variety of techniques
- Create a strong, fact-driven legal analysis that is responsive to the question(s) asked
- Recall and understand the substantive law reviewed in the course

Course Materials

Course Delivery

The course is delivered through a series of modules designed around Contracts, Evidence, Torts, and Real Property. After completing a pre-test, you will be introduced to the Systematic Problem-Solving method. For each subject, you will first view substantive lectures to deepen your understanding of the rules. During class, we will work through questions and guided exercises. After class, you will complete additional assignments.

Online Classroom

There is an online classroom component for this class through BarBri's D2L platform. While we have a D2L course shell through SIU, there will also be a shell in BarBri's platform. This is where you will view lectures and submit assignments. You will receive an e-mail from support@lawstudentonline.com with your log-in credentials to access the online classroom prior to the first day of class. Evaluation


Your grade in this course will be based on:

1. Lecture Scores – 30%

- Each lecture is scored. Your overall “Lecture Score” will be the average of all individual lecture scores. The score on each lecture is based on the number of correctly answered questions embedded in the lecture. However, you are allowed unlimited attempts to re-answer missed questions and bring every lecture score to 100%. The highest score achieved on each lecture will be factored into your overall “Lecture Score.”

You may retake a lecture to improve the score at any point during the course (i.e., you may improve a lecture score after the deadline has passed for that lecture). After the final exam window has closed, any incomplete lectures will be scored as a zero when calculating your overall “Lecture Score.”

You will know you’ve completed a lecture once you reach the final “Congratulations!” screen (see screenshot below). Your score on the lecture will be provided on this screen as well. If you would like to improve your lecture score to 100%, click on “**Retake Missed Questions**” and you will have the opportunity to re-answer any questions you initially answered incorrectly. Your highest score will be counted, so it is to your benefit to correctly re-answer missed questions and bring each lecture score to 100%.



To improve a lecture score **after exiting the lecture**, simply re-open that lecture segment, select “Retake Content,” < “Resume” < “Retake Missed Questions.”

2. Quizzes & Performance Task Submissions – 20%

- **NextGen Pre-test:** There is one course pre-test focused on the subjects covered in the course. The pre-test serves as a baseline of your initial knowledge and skills.
- **Retention Building Quizzes:** There are four Retention Building Quizzes assigned in the course (one for each subject). Retention Building Quizzes are scored.
- **Performance Task submissions:** There are three PTs submitted (two for feedback).

3. Midterm Exam – 20%

- The midterm exam will be completed in-person.
- It will consist of 20 multiple-choice questions and one integrated item set.
- You will have 60 minutes for the exam.
- The midterm exam will cover Contracts and Evidence along with NextGen Skills.
- The midterm exam will be closed-book (no materials allowed).
- As your midterm approaches, additional details related to the Midterm Exam itself and exam administration will be available.

4. Final Exam – 30%

- The final exam will be completed in-person.
- It will consist of 40 multiple-choice questions, two integrated item sets, and one Performance Task.
- You will have 3 hours to complete the final exam.
- The final exam is cumulative and covers all subjects and skills in the course.
- The final exam will be closed-book (no materials allowed).
- As your Final Exam approaches, additional details related to the Final Exam itself and exam administration will be available.

You are expected to complete the reading and homework assignments prior to each class. This will include uploading completed assignments to the D2L online classroom. You may be given additional assignments during class. Your Professor reserves the right to change assignments with sufficient notice.

Due dates for every assignment are provided on the course syllabus and course schedule (and posted in D2L). Law is all about deadlines. Missing deadlines, being unprepared for class, or missing meetings can have dire consequences for your clients and for you (malpractice, loss of respect from the court, discipline from the bar association.) Late work will not be accepted unless prior approval is given. That approval will only be granted in extreme circumstances that are clearly beyond your control. Preparation for class means reading the assigned readings, completing exercises on BarBri, & reviewing all information required for that week.
